### **NIKOS COALGRILL GREEK AND CORONA COMPETITION (TERMS AND CONDITIONS)**

1. This competition (the “Competition”) is conducted by Nikos Advertising (Pty) Limited (“Nikos”) and ABInBev Limited (“ABInBev”) (Nikos and ABInBev together referred to herein as the “Promoters”) and may only be entered into by customers of Nikos Coalgrill Greek restaurants in South Africa who are 18 (eighteen) years or older and resident in South Africa with a valid ID or passport.
2. No persons related to the Promoters may enter the Competition (including but not limited to their subsidiaries and/or franchisees) by way of being:
  - 2.1. directors, members, partners, employees, franchisees, agents of, or consultants to;
  - 2.2. any marketing service provider(s), any supplier(s) of goods or services, any other person who directly or indirectly controls, or is controlled by them; or
  - 2.3. any spouse, life partner, parent, child, brother, sister, business partner or associate of any of such persons.
3. A copy of these Competition rules (the “Rules”) is available on the Nikos Coalgrill Greek website at <https://www.nikosgreek.co.za/>. These Rules may be amended by reasonable notification via the Nikos Coalgrill Greek website at any time during the Competition and will be applied and interpreted by the Promoters and their decisions regarding any disputes relating to such meaning and/or content will be final and binding.

4. Participation by the entrants in the Competition constitutes an agreement to abide by these Rules.
5. Entries for the Competition will run from 09:00 on 14 December 2023 until midnight on 31 January 2024.
6. To enter and to be eligible, entrants must purchase a Corona 355ml from a Nikos Coalgrill Greek restaurant, scan the Service Olympian's QR code card and complete the details as prompted.
7. Each Corona drink purchased in terms of clause 6 above shall allow the entrant to scan the Service Olympian's QR code card in each instance, allowing for multiple entries to the Competition.
8. This offer is only available as a sit-down purchase for consumption on the premises of the relevant participating Nikos Coalgrill Greek restaurant.
9. The Promoters will not accept responsibility for entries that are lost, mislaid, damaged, undelivered, or delayed in transit, regardless of cause, including, but not limited to, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
10. The Promoters reserve the right to disqualify any entrant who breaches any provision of these Rules.
11. 1 (one) winner will be drawn at random at the end of the Competition based on their valid entry.
12. The prize will be a return trip for 2 (two) people to Mauritius to the value of R60,000.00.
13. The prize is limited to the following:
  - 13.1. 2 (two) return economy class flights to Mauritius; and
  - 13.2. Accommodation package for 2 (two) in Mauritius.
14. The prize must be redeemed by 30 April 2024.

15. The prize winners must have valid passports (valid for at least six months from date of return to South Africa), with at least two blank pages in it.
16. The prize will under no circumstances be handed over to a third party and will only be handed directly to the verified prize winner or at the prize winner's written instruction.

19. Processing of Personal Information and Entrant Consent

- 19.1. The entrant's privacy is very important to the Promoters and they will use reasonable efforts to ensure that any information, including personal information, provided by the entrant, or which is collected from the entrant, is stored in a secure manner.
- 19.2. The entrant agrees to give (where applicable) honest, accurate and current information about the entrant to the Promoters and to maintain and update such information when necessary.
- 19.3. The entrant's personal information collected by the Promoters may be used for the following reasons:
  - the processing of personal information on the Promoters' website;
  - further processing by third parties, including the fact that related parties of the company may access information on the Promoters' website;
  - direct marketing;
  - fraud prevention; and
  - SARB and SARS reporting and the like if applicable.
- 19.4. The entrant acknowledges that any information supplied to the Promoters is done voluntarily.
- 19.5. By submitting any information to the Promoters in any form the entrant further acknowledges that such conduct constitutes an unconditional, specific and voluntary consent to the processing of such information by the Promoters under any applicable law in the manner contemplated above, which consent shall, in the absence of any written objection received from the entrant, be indefinite and/or for the period otherwise required in terms of any applicable law.

- 19.6. Unless the entrant has consented, the Promoters will not sell, exchange, transfer, rent or otherwise make available any personal information about the entrant (such as name, address, email address, telephone, or fax number) to other parties and the entrant indemnifies the Promoters from any unintentional disclosures of such information to unauthorised persons.
- 19.7. Should the entrant believe that the Promoters have utilised the entrant's personal information contrary to applicable law, the entrant shall first resolve any concerns with the Promoters. If the entrant is not satisfied with such process, the entrant has the right to lodge a complaint with the Information Regulator of South Africa.
20. The winner will be required to forward a certified copy of their Identity Document and details of their address to the Promoters within the time period stipulated by the Promoters' representative. Every reasonable effort will be made to contact the winner, however if the winner does not respond to the notification/s and/or provide the required documents within 3 (three) days after the Promoters' representative has informed them that they have won the prize, failing which the winner will forfeit the prize and the Promoters will be entitled to redraw to find an alternative winner.
21. The prize is not transferable or exchangeable to the maximum extent permitted in law, the Promoters and their subsidiary and holding companies are not liable for any defects in, or changes to, any part of the prize.

To the maximum extent permitted in law, the owners of any Nikos Coalgrill Greek restaurant, the Promoters, or any of their respective holding or subsidiary companies, or any of their respective directors, officers, managers, employees, agents, franchisees, or anyone associated with any of them, shall not incur any liability to any person for any injury, loss, claim or damage of any nature whatsoever whether direct, indirect, consequential or otherwise, as a result of (or in any way connected to) any person entering into, or arising from any cause whatsoever or howsoever arising from any person's participation in any way, in this Competition or as a result of (or in any way connected to) any prizes won there under, including any tax liability incurred by the winner as contemplated in clause 17 above (any such prizes being utilized and accepted at the sole and own risk of any winner thereof).

In the event of any act of God, strike, war, warlike operation, rebellion, riot, civil commotion, lockout, combination of workmen, interference of trade unions, suspension of labour, fire, accident, or (without regard to the foregoing enumeration) of any circumstances arising or action taken beyond or outside the reasonable control of the Promoters preventing them from the performance of any obligation to an entrant (any such event hereinafter called "Force Majeure") then the Promoters shall be relieved of all such obligations to the entrant during the period that such Force Majeure continues and shall not be liable for any delay or failure in the performance of any obligations or loss or damage which the entrant may suffer due to or resulting from the Force Majeure.
25. The Promoters reserve the right to cancel, suspend, amend, or terminate the Competition at any time and without notice to the entrants.
26. In the event of a dispute in respect of any aspect of the Competition, the Promoters' decision is final and binding and no correspondence will be entered into. In the event of a dispute regarding a winner chosen in accordance with 11 above, the decision of an independent admitted attorney duly appointed by the Promoters will be final and binding and no other correspondence will be entered into.

By entering the Competition, entrants agree to receive further communication and direct marketing material from the Promoters, and their holding and subsidiary companies, provided that the entrants may opt-out of receiving commercial communications at any time via the appropriate opt-out mechanisms provided by the Promoters for such purpose.

This Competition shall comply with, and will be subject to, any peremptory provisions of the Consumer Protection Act (“CPA”) and the regulations promulgated thereunder, which are deemed to be incorporated herein (“Peremptory Provisions”). In the event of any conflict between these Rules and the Peremptory Provisions, the latter shall prevail.
